- _ I agree to take a daily <u>rapid test</u> while on site.
- _ I agree to wear a properly fitted KN94/95 or N94/95 mask when indoors (except when eating or drinking).
- _____I agree to opt out of participating if **any** of the following are true:
 - I currently have a fever or am feeling sick.
 - I have had, in the past 48 hours, any symptoms of COVID-19.
 - I have had close contact with a person who has confirmed COVID-19 in the past 14 days.
 - I have tested positive for COVID-19 in the past 14 days.
- I agree to wash my hands for at least 20 seconds/use hand sanitizer.
- _ I agree to do my best to keep at least six (6) feet of distance between myself and others (or ask for consent).
- _ I understand that my participation in this gathering is entirely voluntarily, and I have carefully considered the attendant risks of such participation, up to and including illness or death.
- _ I understand that I may be at risk of exposure to SARS-CoV-2 and contracting COVID-19 while participating in and traveling to and from this gathering.
- I understand that in the event that should I test positive for COVID-19 while during the training and on site, I will be asked to remove myself from the training room and will willingly do so for the health and safety of others as well as myself.
- I understand that in the event that I test positive for COVID-19 while participating in or traveling to and from this gathering I am solely responsible for the financial implications of rearranging my travel, lodging and/or meals and other accommodations.

Waiver of Liability: COVID-19
